#### Introduction

The purpose of this report is to provide insight to potential improvements on biogas policies in Croatia. Namely, a substantial effort has been made by different ministries to deliver different strategies covering energy, agriculture, environment and waste sectors. In each of these strategies and policies, biogas is mentioned either as one of renewables or as a tool for reaching the aims of the strategy which makes production and utilisation of biogas overlapped and interconnected with numerous strategic documents but without direct focus on biogas and actions how to really support development of biogas sector.

Unfortunately, time and means of the Project were limited for such an important topic and thus, the Report briefly relates stakeholders with possible actions which will improve development of biogas market together with maximisation of its benefits to different goals of Croatian national policy.

The Roadmap contains a brief range of practical recommendations in the area of national and regional policies in order to overcome existing barriers for biogas implementation in large- and small-scale according to different biogas feedstock.

#### 1. Policy roadmap

Production and utilization of biogas from agricultural biomass (harvest residues, manure) and all varieties of organic waste bring simultaneously benefits in terms of renewable energy sources, reduction of methane, a GHG, to the atmosphere, reduction of organic fraction of municipal waste and extending the lifetime of landfills and prevents pollution of soil and waters.

Since biogas benefits exceed the limits of one sector, most often it occurs that biogas is mentioned in numerous legal documents indirectly which actually hurdles production and utilization biogas in practice.

In Croatian legislation, biogas is explicitly mentioned in more than 20 legal documents that are under the authorities of different ministries:

#### 2. Proposed measures

This document proposes forming of a Biogas committee that will be consisted from at least one dedicated person from responsible ministries and relevant institutions in order to evaluate different roles, contribution and expected effects from biogas as well as implementation measures in the respect of:

- 1) biogas contribution to fulfilling OIE targets (RES-E, RES-H, biofuels)
- 2) biogas contribution to fulfilling Kyoto and CLRTAP targets
- 3) biogas contribution as measure to meet Nitrate directive aims.
- 4) biogas contribution as waste management technology for organic fraction of municipal and industry waste, II category and III category of waste.

According to the accessed contribution of biogas to the above mentioned topics, it is proposed that the Committee acts in the following directions:

- 1) harmonization of contradicting or limiting legal issues on biogas
- 2) (re)positioning of biogas within the Decision on establishing the rules on governmental support in respect to the environmental protection (OG 154/08)

- 3) removing barriers for developing biogas market through its most effective contribution
  - a. what are the spatial conditions that a biogas plant has to meet (conditions for obtaining location permit)
  - b. simplification and adjustment of existing procedures for obtaining necessary permits for a biogas production and utilisation
- 4) educating and informing related existing infrastructures (capacity building).
